Description of filling out the statement:

- Four copies of the statement are made according to the format. One copy is kept by the agency compiling it, and the other three are distributed to the Directorate-General of Budget, Accounting and Statistics, Executive Yuan, National Treasury Administration, Ministry of Finance and the Department of Statistics, Ministry of Finance.
- The data used for this statement must be collected and transferred according to the relevant standard operation procedure. The National Property Administration, Ministry of Finance gathers all the data from all the units and compile the statement within three months after the end of the year.
